

Rhode Island Convention Center Authority Invitation for Bids for an Electric Scissor Lift

The Rhode Island Convention Center Authority (the "Authority") requests bids from qualified firms to provide a new 37' foot 8" inch work height Electric Scissor lift, Skyjack model SJ4732 E or comparable for purchase for use at the Rhode Island Convention Center, One Sabin Street, Providence, Rhode Island. Specifications for the Scissor Lift can be found on Pages 5 and 6 of this document.

To the extent the Bidder intends to offer a comparable scissor lift, Bidder must submit with its bid the specifications of the scissor lift it is offering.

The Scissor Lift will be new and the latest state-of-the-art production model. The design and manufacture of the scissor lift shall be suitable for the intended use of the machine. Materials and finish shall be of the type to resist wear and corrosion from normal use and natural elements. The machine shall meet or exceed the following specifications:

- The scissor lift's manufacturer shall provide parts and service manuals with the machine. The machine unit shall include parts, maintenance, and shop service manuals.
- The scissor lift shall be delivered completely and ready for operation.
- A vendor service representative shall install the Scissor Lift on-site and provide user training.

Added Options:

Option 1: Bidder is encouraged to submit an estimate to provide extended warranty coverage, for a period of three (3) and five (5) years after the initial warranty has expired on product.

Option 2: Bidder is encouraged to submit estimates to provide **ELEVATE** branded telematics three (3) and five (5) year plans.

Option 3: Bidder to also provide a scissor lift lease to purchase option.

Submission of Bids

Submit three (3) properly executed bids with any other documents required to be submitted in a sealed opaque envelope. The envelope shall be identified with the Bidder's name and address, marked "Scissor Lift Bid" and delivered to the following address:

Immediately thereafter, Bids will be opened and announced at the Amica Mutual Pavilion 3rd floor Boardroom, located at 1 LaSalle Square, Providence, RI 02903. Bids received after that time and date will be returned unopened. The Bidder shall assume full responsibility for timely delivery at the location designated for the receipt of Responses. Oral, telephonic or telegraphic bids are invalid and will not receive consideration.

Instructions to Bidders

- 1. The bid must be signed by an officer of your firm with the authority to commit to the firm.
- 2. It is the intent of the Authority to purchase items that are operable within the system outlined in this Invitation; therefore, the Bidder is required to deliver a complete, working product. Should it be discovered that the Bidder failed to identify equipment required for fully operational systems, the Bidder shall supply those items at no charge to the Authority. This includes ALL of the hardware.
- 3. All prices shall be **FOB Rhode Island Convention Center**, 1 Sabin Street; Providence, RI 02903.
- 4. The successful Bidder must maintain a local service department within a 50-mile radius of the Rhode Island Convention Center and stock sufficient replacement parts and equipment components to provide the specified warranty service. The Bidder must be able to provide prompt, on-site service not to exceed a 24-hour response time, Monday through Friday.
- 5. Delivery (including inside delivery to site) must be included in the bid.
- 6. The contract awarded as a result of this RFP will be a firm one-time contract.

Form and Style of Bids

Bids must include the following:

- Company History/Qualification
 - o Provide a detailed history of Bidder and a statement of qualifications
- References
 - o Provide three (3) references who Bidder sold scissor lifts to on the attached sheet stating name, title, company, address, and telephone number
 - o All Responses shall be typewritten without erasures or deletions.

Each copy of the Bid shall include the legal name of the Bidder and a statement identifying the Bidder as a sole proprietor, partnership, corporation, or other legal entity as appropriate. Each copy shall be signed by the person or persons legally authorized to bind the Bidder to a contract. A response by a corporation shall further give the state of incorporation and whether the Bidder is qualified to do business in Rhode Island as a foreign corporation. A Bid submitted by an agent shall have a current power of attorney attached certifying the agent's authority to bind the Bidder.

Selection

The award shall be made to the responsive and responsible Bidder whose bid price is the lowest evaluated or responsive bid price.

RIGHTS RESERVED TO THE AUTHORITY

Whenever the Authority deems it to be in the Authority's best interest, the Authority reserves the right, in its sole discretion, to cancel this Invitation to Bid, to reject any and all bids, to waive minor irregularities or informalities in a bid; to re-advertise; and to proceed in a manner other than awarding a contract under this Invitation. The Authority will not waive the requirement that bids be received by the Authority prior to the deadline for submission.

The Authority reserves the right to cancel negotiations with any Bidder at any time prior to a contract being fully executed by the proposer and the Authority.

The Authority reserves the right to interview any or all Bidders.

In addition to any other cause for rejection of a submittal stated in this Invitation, a bid may also be rejected if there is evidence of collusion among bidders, if the Bidder submitting it is in default or arrears under any prior or existing contract with the Authority or any other State of Rhode Island department or agency, or there is an unresolved claim between the proposer and the Authority or any other State of Rhode Island department or agency.

Any direct contacts made or attempted to be made by any Bidder with any Authority Board member prior to the selection of qualified bidders will automatically disqualify a proposer from any further consideration.

Bidders are considered to be irrevocable for a period of not less than sixty (60) days following the opening date and may not be withdrawn except with the express written approval of the Authority's Executive Director.

Bidders are advised that the Authority is a quasi-public agency of the State of Rhode Island and its records, including statements submitted in response to an Invitation are public records unless otherwise exempted under state law.




